LOCAL ECONOMOMY

- Support the purchase of handicrafts made in the region, this will help and contribute to the growth of the destination's economy.
- That your visit is highlighted by the respect and kindness of the local vendors, promoting a commercial, voluntary and fair relationship between tourists and natives.
- Do not buy products that appear to be false or that their sale is prohibit by national or international standards or titles.
- Preferably use tourist services that are operated by the inhabitants of the destination.
- Find out about the products that have no legal validity for the departure or entry into the country.

ENVIRONMENT

VECI TRAVELER,

- Purchase products that do not require the use of plants or animals that are endangered.
- Make group activities, with this you will minimize the expense of resources, money, fuels that generate environmental pollution and in this way will reduce the carbon footprint in the environment.
- Reduce, reuse and recycle solid waste that can be generated during your trip, always carry your own bottle of water so that you can use it again, avoid using plastic bags, remember that they are NOT BIODEGRADABLE, then contribute to the inevitable serious pollution.
- Reduce the consumption of water and electricity in the places where you stay (turn off lights when you are leaving, close the wash while you wash your teeth and hands, control air conditioning).



NATURE, PATRIMONIAL, ARCHEOLOGY

- Try not to leave the garbage that you can generate in your visit, you could alter the ecosystem of the wild fauna you would also contaminate the landscape for the rest of visitors.
- Choose routes that generate the least impact on the landscape, choose existing roads and sewers, in this way you will avoid accidents and reduce unnecessary erosion.
- Do not incur environmental crimes, if your visit is in protected areas remember that there must be a regulation and that it was created with the sole purpose of preserving places like this.
- Do not feed wildlife.
- Respect the established signals and indications of the destination you visit, this will generate a safer environment for all.
- Do not withdraw natural resources without authorization this could create a misunderstanding.
- Contribute to the care of the infrastructure that is in the different areas, use the facilities properly, remember; They are conditioned so you can have a pleasant visit.

There are people who use the tourist as victims for the illegal handling of ILLICIT DRUGS.

- Do not carry articles from any other person.
- Do not lose sight of your luggage
- Buy souvenirs from knowledge places.

There is mass production in the market of products that do not meet the ethical criteria of manufacture, YOUR FORGERY IS CONSTANT.

- Do not buy products that in the normal market will cost more.
- Do not buy a product that from the beginning does not generate sufficient confidence.
- Do not let yourself be coerced when you are buying a product, there can be people who do not have ethical values.

TRAFFICKING PEOPLE is more common than you think, so if you suspect that a person is being forced or forced to take any action against their will.

- Inform the nearest authorities.
- Do not act alone, there are authorities trained to handle these situations.

ILLEGAL TRAFFIC OF FAUNA AND FLORA

The Colombian Penal Code establishes penalties of up to 90 months in prison and fines of up to 15,000 minimum wages for those who commit the crime of illegal trafficking of wild flora and fauna.

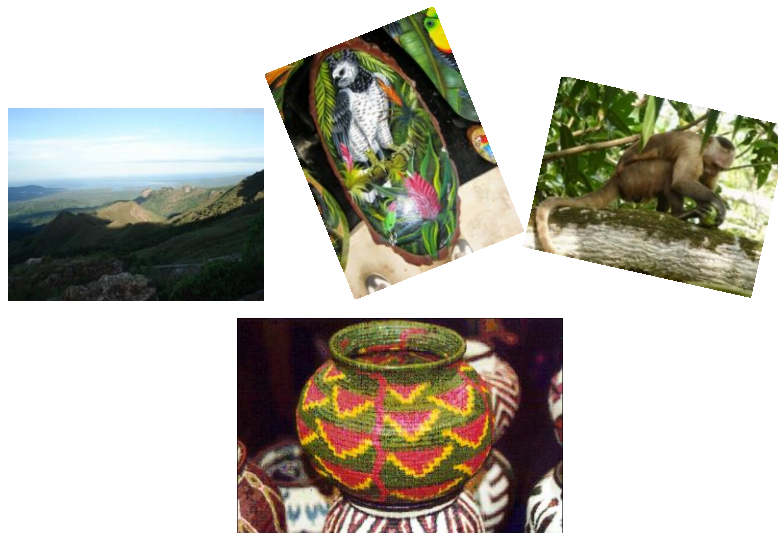
- Take first aid items with you.
